I have many liberal friends acquired over the years. They are impossible to avoid in the media, but I don't wish to avoid them. They became my friends because I stopped seeing them as labels and began seeing them as persons with innate worth. That is what I failed to do in my first response to Rachel Maddow. One might expect a pro-lifer like me to support the birth of fellow human beings and not suggest they should never have been born.

I expect to like Rachel Maddow because my instinct is to separate the value of a person from his or her political position. For some strange reason (demon possession, perhaps) I failed to do that at CPAC.

So, apology delivered and accepted and lunch will soon be served. I'm trying to decide whose career might be hurt more should someone take a picture of us enjoying a meal and –it is to be hoped, at least by me – each other.

Opinion: Proposition 13 is outmoded

Ever since its passage, Proposition 13 has been the “third rail” of California politics: Political leaders touch it at their peril.

We think it's time to take a fresh look.

Our two organizations released last week the 2012 Silicon Valley Index, a comprehensive analysis of our region's health. The report is filled with encouraging news about our regional economy, including a rebound in the tech sector and the revving up of our innovation engine.

But the same report shows local governments in a state of crisis, with decreasing revenues and rising expenses, no longer able to provide the essential social services and capital investments we need to sustain vibrant communities.

Even a stunning economic recovery won't address our fiscal woes. That's because our state's tax system, geared toward an early 20th century economy, no longer tracks with the 21st century economy that is being invented in Silicon Valley.

Our current system is based on taxing sales in brick-and-mortar establishments, on the most volatile sources of personal income (stock options and capital gains), and – increasingly – on property taxes.

However, today's knowledge economy increasingly provides goods and services through the Internet without providing needed tax revenue for state and local governments.

Opinion: Governor's tax ideas are bad for California

This month marks Presidents Day, and as we celebrate Lincoln's birthday it's timely that we look at the tax farce troubling his home state of Illinois. Last year, in a move that must have left legislative Democrats dizzy with admiration and envy, the Illinois Legislature jacked personal income tax rates up by 67 percent and corporate tax rates up by nearly 50 percent.

Despite assurances that were made when the taxes were passed, the legislature still has not closed their budget gap, and they won't until they get the political will to control their spending.

Let Illinois be a lesson to everyone who believes in the magical powers of tax increases. They do not occur in a vacuum. Unless governments have the discipline to rein in spending – which California certainly does not – tax increases just enable more extravagant spending plans and takes money away from the working families who have earned it.

California's problem is not that the people are taxed too little, but that the government spends too much. We have to examine every possible avenue for saving money so that we can keep providing core government services, such as education and public safety, at a price we can afford.

For example, why does California have a full-time Legislature? Texas and more than 40 other states do just fine with part-time legislatures that meet far less often than California's and where the legislators make far less than we make every year.

Besides the savings, it's a good idea to get legislators away from the Capitol cocoon more often and out in the real world, living and working under the rules they pass in Sacramento. I own a business and I'm constantly frustrated by the maze of regulations that grows and changes with every legislative session. I know how hard California makes it for businesses to succeed.

In my business I can't just keep spending and spending and then force my clients to pay more and more to cover my spending. When times are tight, I have to cut back, find ways to save money, provide the same services more efficiently.

Government should be taking that same approach, when unemployment is eleven percent and state government is running multibillion dollar deficits. Now is not the time to be growing government.

But, incredibly, Gov. Jerry Brown's budget plan spends \$6 billion more in 2012-13 than in 2011-12.

And to pay for it, Brown and the Democrats want to pass the bill along to their customers. The governor is pushing for a five-year, \$35 billion tax increase. Sales taxes and income taxes will go up during those five years, costing families precious dollars that they could use for groceries, vacations, school clothes and thousands of other necessities that are already hard to afford in our high-cost, highly regulated state.

Let's take a private-sector approach before we shake down taxpayers any further. How about putting a stop to the \$100 billion-plus high speed rail plan that will soak up billions of dollars a year for decades? How about allowing schools to contract with the private sector to provide services like transportation or food service?

I oppose Brown's call for higher taxes. State tax rates went down last year, but state tax revenues are growing and are expected to continue growing for the next several years. This indicates that our economy – slowly and precariously – is moving forward. Let's not kill that momentum by larding on even higher, unnecessary taxes.

appears to have a slight**

heart beat

Redevelopment is dead after more than six decades as a multibillion-dollar government economic development tool.

Or is it?

As the decree to kill redevelopment takes effect, the Capitol is buzzing with efforts to bring it – or something like it, or some substitute – back.

Gov. Jerry Brown nixed redevelopment advocates' efforts to delay its execution by 10 weeks, supposedly to give the 400-plus local agencies more time to make an orderly shutdown, but in reality to keep it alive in hopes of a reprieve.

"I don't think we can delay this funeral," Brown said, making it clear that he'd veto any extension bill.

Senate President Pro Tem Darrell Steinberg, who had voted for redevelopment's death sentence last year, popped up with Senate Bill 654 to let cities retain the low-income housing funds that redevelopment agencies had amassed, rather than having them distributed to schools and other local governments.

If enacted, it would hold back \$1.4 billion, eating into money that Brown wants from redevelopment's demise by shifting their funds to school districts.

Opinion: Find a way to keep state parks open

California's state park system was established in 1926. Ranging from San Onofre State Beach in Southern California to Del Norte Redwoods in the north, California's 270 state parks include historic treasures such as California's missions, Fort Ross and our first state Capitol, as well as natural wonders like Lake Tahoe, the redwood forests and Castle Crags. Our parks provide summer vacation sites for families, as well as destinations for tourists from all over the world.

Our parks belong to the people, and the people have loved them and invested time and money in them. While I applaud the *Press Democrat's* support for keeping our state parks open ("State parks need allies not rivalries," Sunday), I am dismayed that the *Press Democrat* fails to recognize the real problem: the state is actively undermining ongoing negotiations with local nonprofits.

Nonprofit supporters were in the process of developing operating agreements for several beloved North Coast parks – Hendy Woods, Russian Gulch, Standish-Hickey, Westport Union Landing, Austin Creek and Sugarloaf Ridge. Local citizens were actively engaged in developing these operating agreements to save their local parks. However, the state has delayed its negotiations with these nonprofits, while at the same time developing requests for proposals aimed at private, for-profit companies.

Fortunately, the state backed off its proposal to privatize 11 parks in their entirety after being faced with stiff opposition from myself and others and with increased media scrutiny. However, the state is proceeding to seek bids for

concessions from for-profit companies to take over some operations in these parks.

Opinion: Keep strong, independent media alive

The Fourth Estate. That has long been the media's role. We are there to ask the tough and unpopular questions. We are there to report the answers.



What happens if no one asks those questions?

Now in my third decade as a professional journalist, I have seen plenty of changes through the years. Two things I embrace – the choice of news outlets beyond the three networks I grew up with and the ability to get real-time news instead of the three-hour tape delay TV news broadcast.

In some ways, those are also the two things that bother me the

most about the changes in the news industry, too. Choice is great – but at what cost? With so many niche publications – online, print, TV – many people are not getting a breadth of news. It's focused, targeted – almost written just for them. I worry if people don't read things beyond what they are interested in, as well as things they disagree with, that we will have an ill informed society. And what happens when those people go to the ballot box?

Not every story is fun to read. Trust me, they aren't fun to report or write either.

If I could just write what I wanted, it would be food, outdoors and travel stories. But as much as I need to write about other things, I firmly believe we need to be reading all the other things.

Real-time news is great. But accuracy should come before being the first to report something. Old-school? Perhaps. But it's what is so often missing with the 24-hour news cycle. We equate "best" with being "first" – not "best" with having the "best" story.

It's getting harder for news outlets of any kind to deliver in-depth stories. That 24-hour cycle is part of the problem. The media is in a bit of a game of trying to keep up with the Joneses. It's not serving the public well.

The other problem is the lack of revenue media has. Newspapers blew it when they gave away their content for free on the Internet. It made entities like *Lake Tahoe News* unable to charge for content. It's just not mainstream to do so or something the public has an appetite for.

But it takes money for all media outlets to survive. In-depth stories like the two-part series on drugs on the South Shore that will run on *Lake Tahoe News* Feb. 17-18 take money to produce. People forget that reporters still cost money. It doesn't matter that their stories are online. The same amount

of work goes into a well researched, well written, well edited story no matter the medium.

Opinion: Schoolchildren showing importance of state parks

Publisher's note: *This editorial is from the Feb. 12, 2012, Sacramento Bee.*

Slowly but surely, nonprofits and local communities are exploring what they can do to keep open the 70 state parks slated to close on July 1.

So far, 10 parks have been removed from the closure list. The latest is a gem in our region, the South Yuba River State Park, with a lovely canyon and covered bridge, near Grass Valley.

Elementary school students at the public Grass Valley Charter School were among those who lobbied local leaders and helped the South Yuba River Citizens League collect 10,000 petition signatures. The Nevada County Board of Supervisors, the Nevada City and Grass Valley city councils and Truckee Town Council signed a letter to the governor.

State Parks officials announced Wednesday that the park will remain open, with new parking fees at entry kiosks and self-serve devices at park entry sites. Nevada County agreed to “no parking” signs along the public road adjacent to the park, so visitors will use the park’s lot and pay the fee.

The kids and the community still are trying get neighboring Malakoff Diggins State Historic Park off the closure list. That’s the site of the largest hydraulic mining operation in California in the 1870s and early 1880s.

Other parks have gotten off the closure list with timely donations and active nonprofits.
